

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 184.7 tCO₂e by 2028. This is a reduction of 22.7 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline and the measures will be in effect when performing the contract. The carbon emission reduction achieved by these schemes equate to 48.2 tCO₂e, a 20.2% reduction against the 2023 baseline.

- Moved from UPS to DPD who have some electric vehicles.
- Put signage up in offices and toilets to turn off lights and taps

In the future we hope to implement further measures such as:

- Plan to use public transport for journeys where possible
